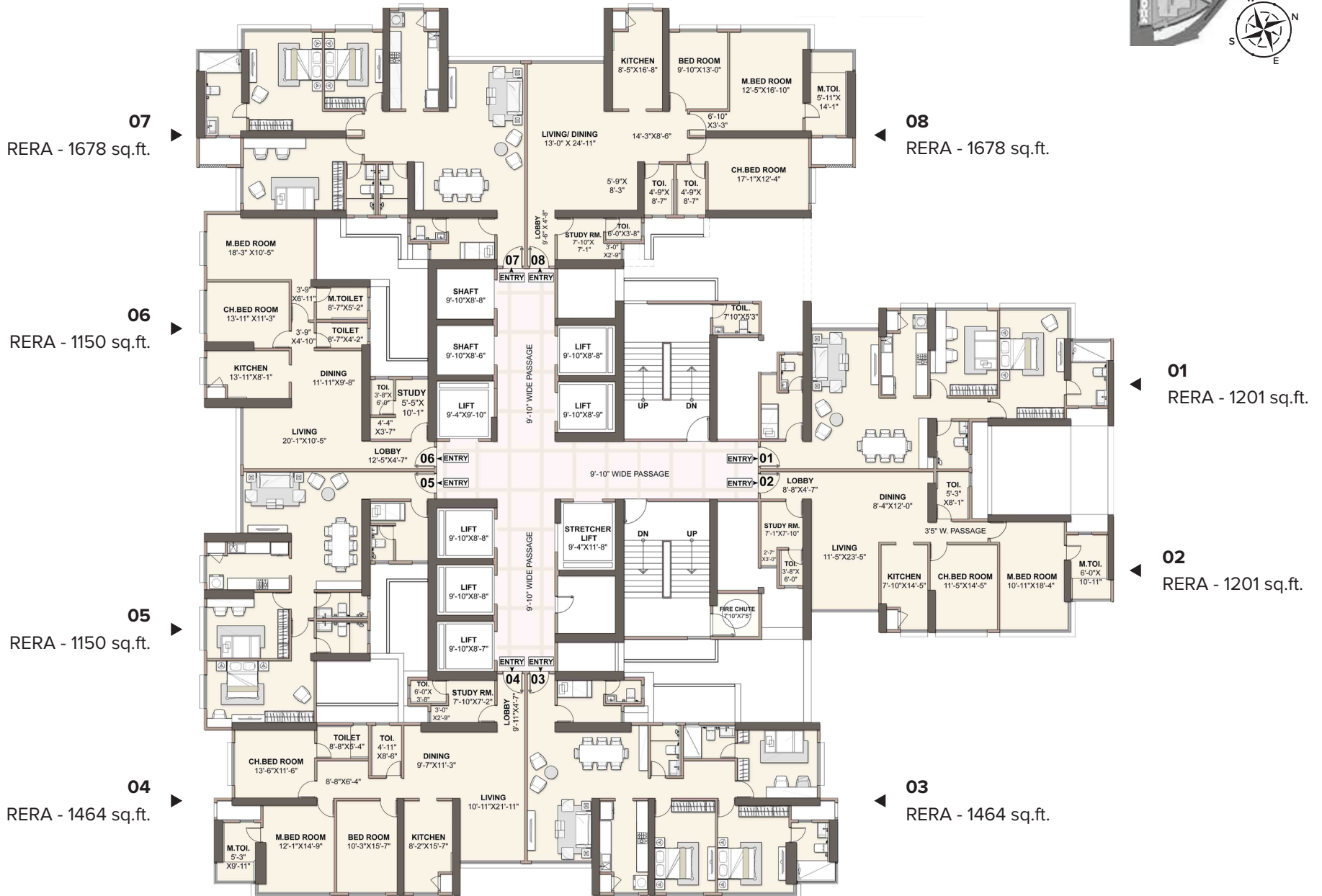

(without deck)

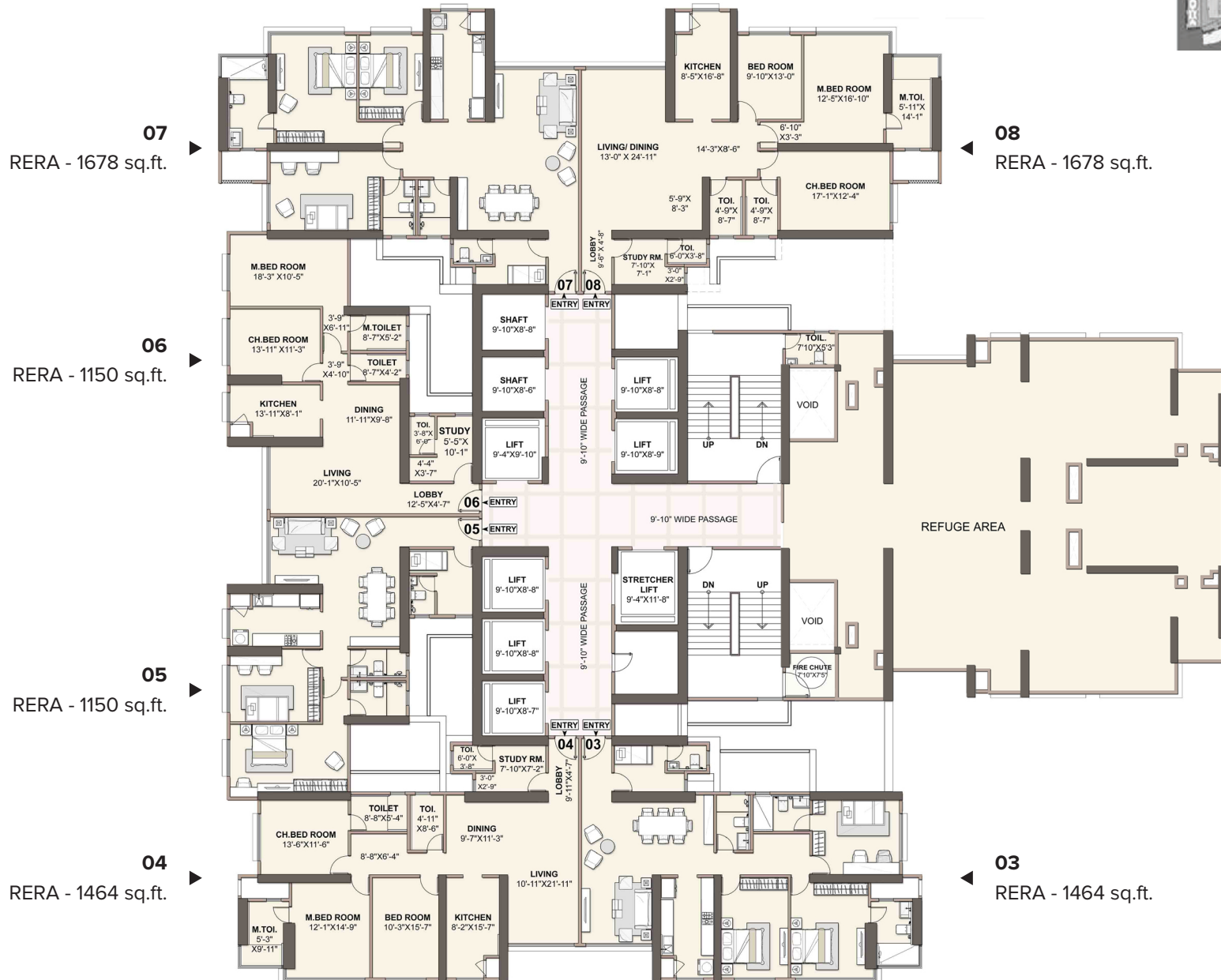

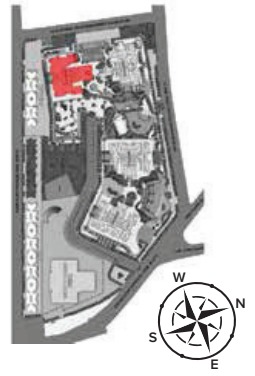

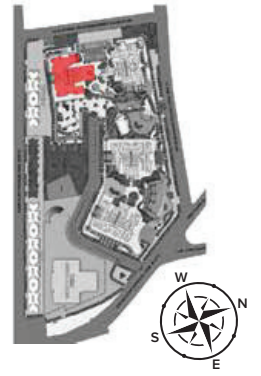
